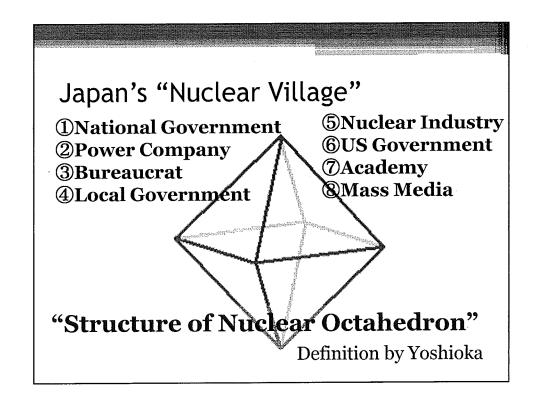

This paper examines socio-science (politico-science?) relationship between Japan and Indonesia through discussing nuclear engineering. The term "Nuclear Village" has been commonly used to criticize the syndicate of the nuclear industry, electric power companies, national and local governments and research institutions. Japan has given Indonesian students opportunities to study nuclear physics at the Tokyo Institute of Technology (Tokyo Tech), Japan's best technical university. Tokyo Tech alumni are among the most prestigious scientists in Indonesia. Japan educated Indonesian nuclear experts dominates the nuclear related institutions such as National Atomic Agency, Nuclear Regulatory Agency and the Bandung Institute of Technology (ITB). The Japan Indonesia nuclear network is orchestrated by the Tokyo Tech ITB nexus. At ITB, the best technological university in Indonesia, all physics professors obtained academic degrees from the Research Laboratory for Nuclear Reactors at Tokyo Tech. By biographical and bibliographical approach, this presentation analyzes how and why nuclear experts interact between Japan and Indonesia.

Nagai Takashi and Radiology in Pre-war Japan

Nagai Takashi (永井隆, 1908-1951) was one of the best-known *hibakusha* survivors of Nagasaki. A medical doctor and a devout Catholic, he became famous for his prolific literary output after Japan's defeat in the Second World War, with his memoirs about Nagasaki, the atomic bombing and his own family, becoming best-sellers in Japan and translated into many other languages. Nagai's writings and legacy are frequently discussed within the fields of peace studies and atomic-bomb literature. However, scholars have engaged far less with Nagai's main occupation: that of a radiology specialist engaged in the frontlines of public health and scientific research during the war. In this presentation, using his published writings, I examine Nagai's work as a radiologist before 1945, and his attitude towards medical science and radiation in medical diagnosis and treatment. This is not only to provide another perspective on understanding his significance as a historical character, but also as a case study in how radiology and X-rays are implicated in understandings of radiation illness in modern Japan.

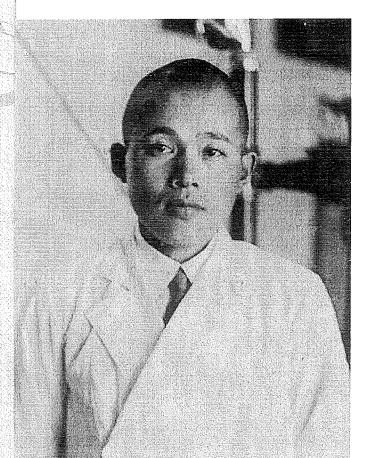

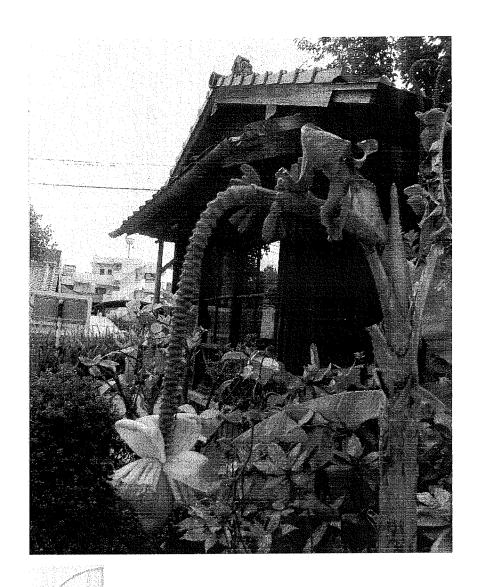

- 1937: Military medic in the Shanghai Incident.
- 1940: Promoted to assistant professor of radiology; promoted to dean
- 1945: Survives atomic bombing of Nagasaki
- 1947: Moves into Nyokodo (如己堂) with his surviving family
- 1950: Awarded Prime Minister's Award for contributions to post-war reconstruction

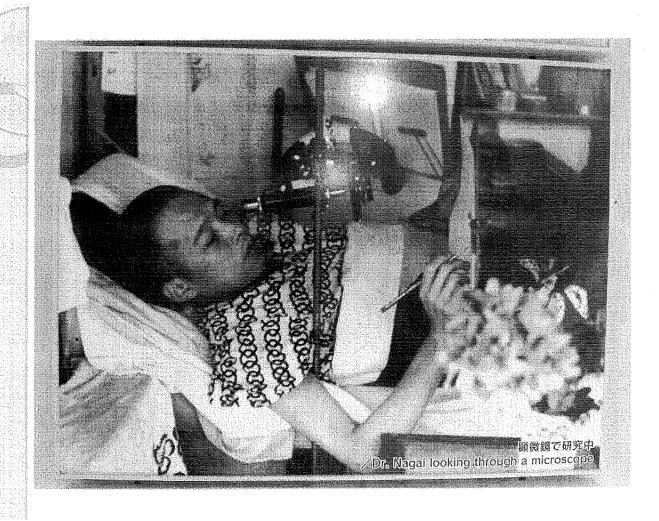


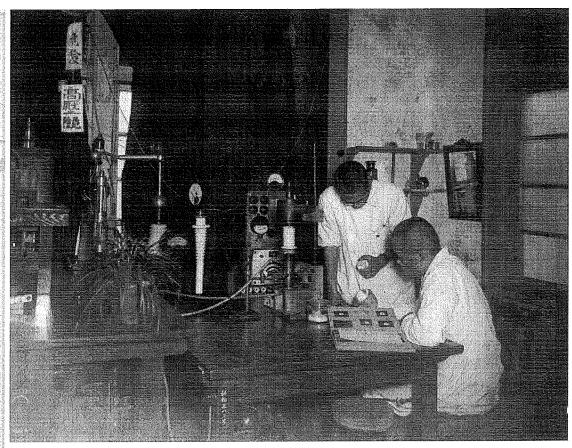

If a university professor really is supposed to grasp the truth, it would be impossible for me to hold that post even for a day. I had an utter lack of confidence, and was ashamed of my lack of knowledge; lecturing in front of an audience was terrifying, and though I had grappled with X-rays for the past twenty years, it was just as their discoverer, Professor Roentgen, had named these mysterious rays. I was covered in an unknown number of Xes; the more I researched, the more of them they were. Sometimes I even thought that I would quit this unmasterable field of learning and specialize in a different subject.

Ryūkichi [a fictional name Nagai gives himself] gazed at the rentogen machine which had shortened his life. The radiation it emits is killing me. He tried to pursue this thought, but strangely enough he felt not a particle of hatred. — For this machine had, for a long time, been Ryūkichi's friend. Without it, Ryūkichi might not have done any work. It had birthed the many papers he had presented to the academy. It deserved thanks for the many students, Ryūkichi included, who had studied and accumulated fruitful experiences through using it. Even more crucially, it had given thousands of patients accurate courses of treatment, allowing them to survive in precarious situations.

The machine's rack was coming apart in places; its cables were repaired with wrappings of electrical tape, and the growl of its transformer had acquired a staticky noise. It, too, was already aged and fatigued, nearing the end of its life. Ryūkichi was the one who had used it to such a state. If this machine had a soul, it would doubtless share Ryūkichi's sentiments.

Atomic Illness

Atomic illness is a malaise caused by the radiation that is released when the atom is destroyed. It is a disease of civilization, the black thorn that lurks in the shadows of science's riotous blossoming.

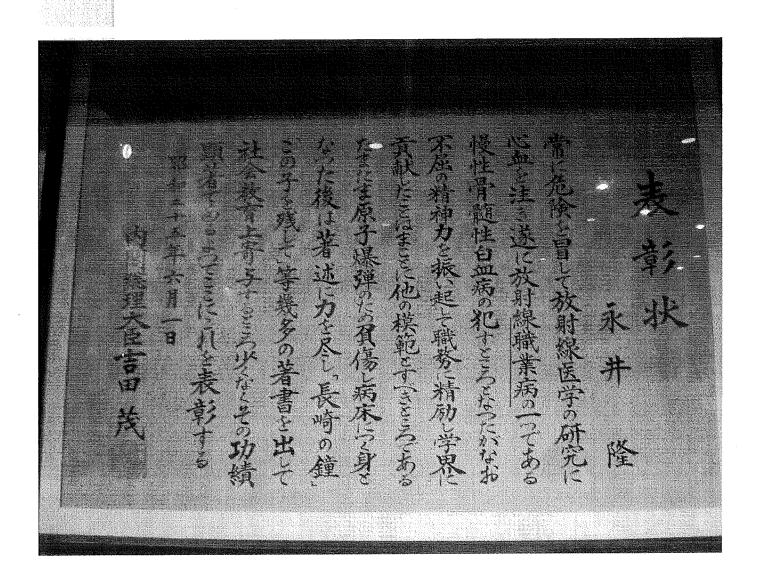

A good deal of research concerning the effects of radiation from nuclear fission on living things had already been done in clinical tests and experiments with different kinds of animals before the atomic bomb exploded. Although the reaction is different between a large amount of radiation released over a short period of time and a small amount over a long period, radiation always has a destructive effect on tissue cells.

Japanese Doctors in Hiroshima during the Occupation age: Between Local Science and American Science

Maika Nakao (Keio University)

It took several years and even decades for the radiation sickness caused by atomic bomb to be fully uncovered. Several symptoms gradually emerged among the survivors of the atomic bomb and they lived in fear for its symptoms. During this time, from 1945 to 1952, Japan was occupied by the U.S. and the information regarding radiation effects was restricted to disseminate. Previous scholars had been examining this America's "cover-up" of information and much less paid attention to the Japanese interpretation of radiation sickness during that period. In fact, the Japanese doctors who made clinical examination of survivors speculated in many ways about the symptoms and stated it to the public media. However, they committed oversights or miscalculation. How did the doctors made miscalculation and how did they uncovering the mechanism of the radiation sickness? By examining local doctors' activities in Hiroshima, this paper discusses the knowledge transfer of radiation sickness during the period of U.S. occupation and argues that the knowledge was created and transferred in between local science and American science.

Introduction

- ◆ It has been said that the entire image of atomic bomb casualties were not seen in the public media for several years after the bombing.
- Previously, scholarly works tended to focus on America's "coverup" of the information.
- ◆ The Japanese doctors who made clinical examination of survivors speculated in many ways about the symptoms and stated it to the public media.
- ◆ How did the doctors make miscalculations and how did they uncover the mechanism of the radiation sickness?

Introduction

- This paper focuses on the discourse regarding the disease caused by the atomic bomb in both public and professional media and discusses the knowledge transfer of radiation sickness during the period of U.S. occupation.
- This paper argues that the knowledge was generated and exchanged between local science and American science.

Atomic Bomb Injury (原子爆弾症)

- ◆ First: people were killed by the heat and the massive blast, in the immediate aftermath, or a few days after the bombing.
- ◆ Second: the people who were unhurt, at first, began to experience nausea and diarrhea, hair loss, subcutaneous bleeding, and death from mid-August to early October. acute radiation syndrome
- ◆ Third: until December 1945, it seemed that the symptoms settled down (recovery period).
- ◆ Fourth: The following conditions began to inflict survivors from around 1946: leukemia, cataract, and birth abnormality. *late radiation syndrome*

Unknown Disease

- Several symptoms gradually emerged among the survivors of the atomic bomb and they lived in fear of its symptoms.
- The atomic bomb survivors suffered not only bodily damage but also **mental** and **social** damages.

The First Stage

- Soon after the American atomic attacks, Japanese **national newspapers** began to report about the bomb.
- Japanese scientists began to survey the nature of the atomic bombs.
- The articles pointed out the existence of radiation and residual radioactivity.

"Weird Disease" to "Atomic Bomb Injury" The Second Stage

- Around mid-August 1945, people died from a "weird disease."
- In 24th August 1945, when an actress named Midori Naka died in the Tokyo Imperial University Hospital after she suffered from an atomic bomb explosion in Hiroshima, the attending physician Masao Tsuzuki named it as the "Atomic Bomb Injury."

Medical Investigations The Second Stage

- Kyushu Imperial University (九州帝国大学) and Tokyo Imperial University (東京帝国大学).
- National Research Council of Japan (学術研究会議) set up a Special Committee for the Investigation of the Atomic Bomb (原子爆弾災害調査研究特別委員会).
- The American Team
 →Atomic Bomb Casualty Commission (ABCC)

The Third and Fourth Stage

- It seemed that the atomic bomb injury was gradually settled down
- However, in reality the atomic bomb injury was not settled down

Local Publications

- The local newspapers such as *Chugoku Shinbun* (中国新聞), Yukan Hiroshima (夕刊ひろしま), and Nagasaki Times (長崎タイムズ) carried much more information regarding the atomic bomb and atomic bomb injury.
- Local newspapers were valuable source of information for the survivors.
- The local doctors provided information about the injury.

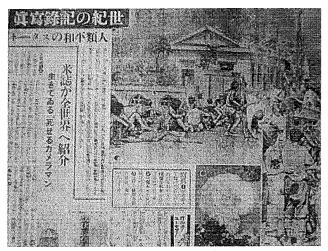
Deny of Atomic Bomb Injury

- Dr. Akiyama at the Hiroshima-Teishin Hospital denied sterility and birth abnormality. (June 23, Yukan Hiroshima & July 10, 1946 Chugoku Shinbun)
- "Don't worry about infertility. There will be no birth abnormality." "It is OK to marry. Ladies with picadon sickness, please feel at ease. You are not infertile, your babies will not be malformed." (Chugoku Shinbun, July 10, 1946.)

Censorship?

- Shigetoshi Itokawa (糸川成辰) head of the editing office of the *Chugoku*.
- "There wes no overt censorship and I didn't get any complaints.[...] I have learned from American newspapers that the press ought to report after careful examination."
- 「プレス・コードによる公然としての検閲はなく、私のところへは具体的には何もいってこなかった。占領軍の任務遂行、政治上の意味を除いたら、プレス・コードのいう客観報道、早く正しく、真実の報道は新聞の常識といえる。アメリカの新聞の持っているルール、事実をよく確かめてから、よりよく報道する姿勢には学ぶところも多かった。」『中国新聞八十年史』

Michihiko Hachiya (1903-1980)

- Born in Okayama. Graduated from Okayama Medical University(旧制岡山医科大学) in 1929 and became the hospital director of Hiroshima-Teishin Hospital from 1942.
- He is the author of the book Hiroshima Diary. In it, he describes 56 days of experience in Hiroshima from August 6 as a hospital director. Hiroshima Diary became the best seller and translated into 18 languages.

Background of the Denial

- The difficulty to put a patient's individual case into epidemiological analysis.
- Local hospitals did not have the mechanism to gather information on the symptoms that progressed at slow and large scales.
- However, the fear of atomic bomb injury was ingrained in people's minds.

Background of the Denial

• The medical discourse was built upon people's intense anxiety and the desire to overcome the past.

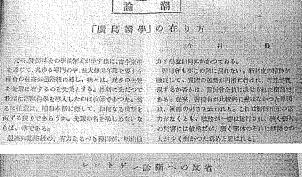

- In August 1948, Michihiko Hachiya stated, "Atomic Bomb Injury has disappeared. We would like to confirm the fact that we are free from Atomic Bomb Injury and have a peace memorial day with a happy mind."

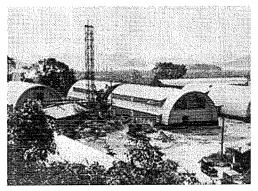

Conclusion

- In the local publications, local doctors contributed to newspapers in response to atomic bomb survivors' anxiety.
- The mechanism of denying the atomic bomb injury occurred in a local context. The survivor's never ending fear on radiation sickness forced doctors to deny it.
- Atomic Bomb Injury was seemingly forgotten in negotiations between doctors and patients, past and future.

Conclusion

- People in Hiroshima tried to overcome the bomb with reconstruction.
- "Atomic Medicine (原子医学)" was a good slogan for that purpose. Hiroshima should be a leading-edge of the Atomic Bomb research.

The Radiation Effects Research Foundation (RERF) in Hiroshima, Japan, was created in 1975, as a reconfiguration of the joint US-Japan Atomic Bomb Casualty Commission (ABCC). It has gradually become a global resource for planning studies of human risk in the wake of disaster. Scientists at the RERF have been consulted in the wake of every radiation accident since the 1970s, have played a critical role in planning long-term studies of populations exposed at Chernobyl and are now engaged with studies of workers exposed at Fukushima. But their approaches are relevant not only to radiation-related disasters, but to all kinds of complex technologically-mediated collapse.

Oriented not around a specific problem or disease (eg cholera or smallpox) or around a population identified first by some clear medical parameter (men over age 40), the RERF's research has instead been organized around a chaotic disaster, the precise details of which are still being actively reconstructed 70 years later. A new reassessment of dosimetry is underway today, drawing on photographs of two cities that are gone, taken before the bombings during the Second World War-photographs of ghost cities, of buildings that burned in August of 1945. This unusual research institute has of necessity developed sophisticated protocols for both historical reconstruction and for an anticipatory epidemiology that can be adapted to other uncertain and chaotic disaster outcomes.

Scholars in the social study of medicine long ago began to explore the emergence of a social role they called a "patient-in-waiting," produced by uncertain medical diagnostics. The patient-in-waiting, in this analysis, is an individual suspended between health and illness. If screening and diagnostic technologies "make up people" in this way, I would suggest that institutions preparing for disaster do so as well, participating in the production of what we might call *survivors-in-waiting*. The survivor in waiting is suspended between safety and danger, inside overlapping twenty-first century networks of uncertainty, risk and vulnerability.

In this paper, I draw on these frames to explore the history and contemporary practice of the RERF, as a way of exploring Lt. Col. Ritchie's observation: Without people, there can be no disaster.

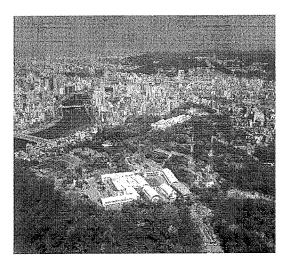

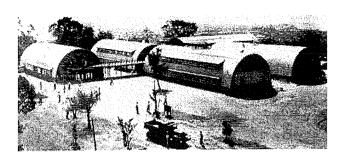
- The reconstruction of a critical moment (where were you?)

RERF today



November 1950

1950 census

- One of the most important triumphs for the developing ABCC was the inclusion of a survey about survivor status in the 1950 Japanese census.
- Having been exposed to the bombs--and therefore qualifying as "hibakusha," a social category by no means desirable--was not necessarily something people wanted to reveal.
- Employment and social discrimination against survivors was widespread. They were believed to be unlikely to be good workers (sickly, at risk for cancer and other conditions) and unlikely to be good marital partners (at risk for genetic effects in their children).
- The numbers of self-identified survivors rose very gradually in the post-war years, and the data from the 1950 census facilitated the creation of a core population of survivors around whom ABCC research could be structured

Reconstructing a critical moment "more than half"

- T65D (tentative 1965 dose) dosimetry calculation in 1965, and with later reports with abbreviated titles for "dosimetry system" the DS86, and DS02 (Dosimetry System reports).
- The types and amounts of radiation released by the bombs at the moment of detonation--the critical moment of exposure, in comparison with which all other exposures were trivial-were not stable, measured, known facts about the world, but frequently recalculated and estimated assessments, grounded in technical uncertainties.
- Generally, the estimates of biologically significant radiation exposure went down over the decades, meaning that all effects documented were the result of exposure to lower levels of radiation--effects of the bombs became more dramatic with time in two different ways, as more cancers and other health effects emerged, and as dose calculations fell.

John Auxier, Ichiban

- Auxier and his group calculated in stunning detail how much and what types of radiation each survivor had been exposed to, based on at least one-hour interviews with over 60,000 survivors, conducted by teams of Japanese interviewers with U.S. observers, over a period of ten years.
- Ichiban replayed the bombings, in the construction of artificial or surrogate Japanese cities in Nevada, and in detailed oral histories which produced a tapestry of physical, medical and social experience, or a tapestry of traumatic memory.
- Database documenting the exact locations of 60,000 people at moment of detonation.
- Auxier recalled his astonishment at the survivors' detailed memories of the moment.

Traumatic memory

"We interviewed her and it was precisely, exactly like the first woman had described it. She knew where the woman who was sweeping [was], where her broom was, she knew where her hand was. It was scary it was so detailed. It was so burned in their memory so much. What they did five minutes later they could not remember. But that instant they remembered, so we had confidence then that mostly people remembered."

Reliving

All epidemiology of disaster risk, by its nature, requires this kind of reconstruction, this reliving or rehearsal of a critical moment in both technological and personal terms.

RERF: Born Transnational

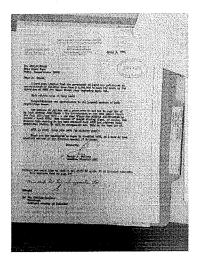
- Originally the Atomic Bomb Casualty Commission (ABCC), a joint project of the governments of the United States and Japan.
- Inflected by political and economic concerns. Scientists are chosen for leadership roles or oversight committee membership based on their citizenship, with a taut balance now required between Japanese, US, and "third-country" scientists, explicitly negotiated in treaties and formal protocols. People chosen to participate in ABCC/RERF activities are often categorized by nationality, and the numbers of Japanese and US participants must be equal. (Biological citizens)
- Not merely a Cold War or Occupation policy. Even the 1995 Blue Ribbon Committee was required to have two Japanese and two third-country nationals appointed by Japan (so, third-country nationals chosen by each of the central nations); and two US nationals and two third-country nationals nominated by the U.S. Department of Energy

National identity and science

Policies express an understanding of scientists as nationalist thinkers, or even as "biological citizens" of a certain kind, who would or could claim biological expertise *based on national identity*. Generally, in blunt terms, US scientists were seen to be more likely to downplay radiation risks and effects; Japanese scientists more likely to overplay them.

Naming

- Darling: "ABCC is dead! Long live ABCC (by whatever name)!"
- · "Institute for Radiological Studies"
- Radiation Effects Research Foundation was opposed by the Japan Radiation Research Society and the Japan Science Council, because it did not mention the atomic bomb.
- One diplomat reported to NAS President Philip Handler in the spring of 1975 that there was in Tokyo "considerable consternation in the nuclear and nuclear-medical communities over the [RERF] name. It is felt to be too all-encompassing."
- Those who studied radiation effects from non-military sources apparently did not want competition from the RERF, because "it has in the past been implicit from ABCC's name that its studies were constrained to the effects of radiation from the atomic bombs upon Hiroshima and Nagasaki survivors and their offspring."
- And the non-medical nuclear community, i.e. utilities, "would like to remain at arms' length from all aspects of radiation effects. They are concerned over a weakening of the association between radiation effects and atom bombs, fearing a stronger association with nuclear power will result."

Epidemiology of chaos

- How to track *everything* just in case?
- How to establish a practical day-to-day system that could pick up unexpected consequences?
- What biological materials should be saved?
- And how to keep such a system going for decades, throughout the life span?

How long is long-term?

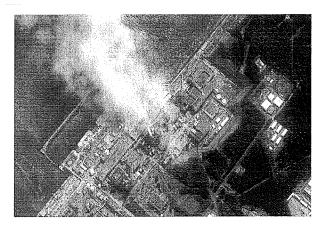
- At first, 5-7 years
- By the 1950s, 1970s; in the 1960s, the 1980s seemed like a natural end; by the 1990s, there were still 20-25 more years ahead.
- Vague expectation of a "natural" ending, one that would reflect the aging of the populations being studied, diminishing returns on the research, the clear emergence of all effects, and the eventual death of most or all of the survivors.
- But studies of the first generation born to the survivors (the F1), of the DNA of survivors frozen in the RERF collections, and of the materials held in tumor registries, have gradually reframed the time-scale, as has the possible emergence of the RERF as a resource for the global management of risk, one that could outlive those whose injuries it was created to document.

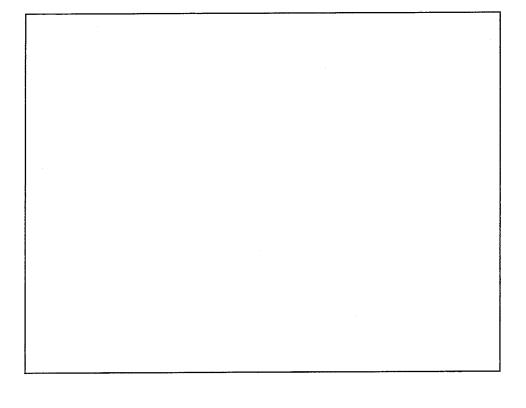
Survivors in waiting

Today, with the 70th anniversary of the bombings approaching in 2015, it seems that the RERF could become a kind of post-survivor institute for the study of risk in general, and a critical site of expertise for what I have come to think of as the epidemiology of forever, or epidemiology without end.

This is an epidemiology for the human condition of the twenty-first century, in which we are all potential survivors--survivors in waiting--of complex and chaotic risk situations, all the time.

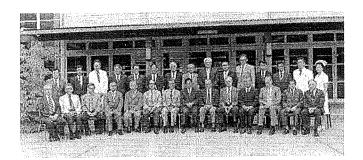

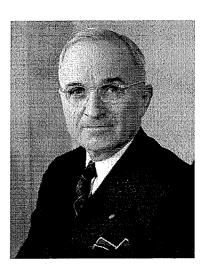
Barbara Allen on Katrina:

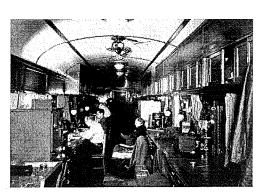
Risk:

- An elaborate technical construction, a property that can be codified in quantitative terms, involving consensus standards for agreed-upon levels that trigger institutional action.
- Personal, visceral, embodied, "individuated," engaged with the direct experience of suffering and with the moral and social problem of anticipatory trauma. By no means is the world of risk calculation void of moral order. It is about the modern calculation of who will suffer, when, and why. *Some level of suffering*, by someone, is built in to most risk calculations.

January 1948 ABCC is relocated to the former Gaisen-kan (the Hall of Triumph), Ujina, Hiroshima. (The Japanese National Institute of Health [JNIH] of the Ministry of Health and Welfare formally joins the ABCC studies.)



November 1946. Financial pressures

- From 1963 to 1973 the costs of the ABCC more than doubled, even though the staff declined by 300 people.
- Japan was contributing significantly less to the project than the United States.
- In 1972 the US contribution was 1.25 billion yen, and the Japanese 74 million.
- AEC was trying to leverage its cooperative work with the Japanese nuclear power program--specifically a deal that involved the sale by the US to Japan of \$320 million worth of fuel for new nuclear power stations-to get commitments for Japanese support for the ABCC..

- Based on the 1950 census

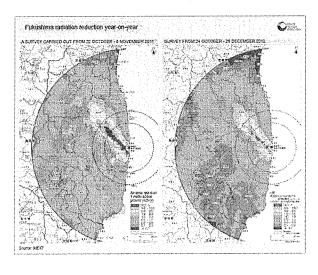
"We could just be manipulating the noise"--1991

- Never found significant differences, for any parameter, between the offspring of survivors and the offspring of controls.
- Neel and Schull in 1991 drew on human and animal data to suggest a relatively high dose.
- In essence, no genetic effects have ever been found, despite dramatic efforts and decades of study.
